MONTHLY ELECTRIC: 30 AMP = \$100.00 per cord and 50 AMP = \$150.00 per cord
TRANSIENT RENTAL: \$3.00 per foot per day (25 ft minimum) plus State Sales Tax
DAILY ELECTRIC: 30 AMP = \$10.00 per cord and 50 AMP = \$15.00 per cord
